ORDER OF DETENTION PENDING TRIALLAWRENCE L. BENNETT*Defendant*

In accordance with the Bail Reform Act, 18 U.S.C. § 3142(f), a detention hearing has been held. I conclude that the following facts require the detention of the defendant pending trial in this case.

Part I - Findings of Fact

- ☐ (1) The defendant is charged with an offense described in 18 U.S.C. § 3142(f)(1) and has been convicted of a (federal offense) (state or local offense that would have been a federal offense if a circumstance giving rise to federal jurisdiction had existed) that is
- ☐ a crime of violence as defined in 18 U.S.C. § 3156(a)(4).
- ☐ an offense for which the maximum sentence is life imprisonment or death.
- ☐ an offense for which a maximum term of imprisonment of ten years or more is prescribed in _____
- ☐ a felony that was committed after the defendant had been convicted of two or more prior federal offenses described in 18 U.S.C. § 3142(f) (1)(A)-(C), or comparable state or local offenses.
- ☐ (2) The offense described in finding (1) was committed while the defendant was on release pending trial for a federal, state or local offense.
- ☐ (3) A period of not more than five years has elapsed since the (date of conviction) (release of the defendant from imprisonment) for the offense described in finding (1).
- ☐ (4) Findings Nos. (1), (2) and (3) establish a rebuttable presumption that no condition or combination of conditions will reasonably assure the safety of (an)other person(s) and the community. I further find that the defendant has not rebutted this presumption.

- ☐ (1) There is probable cause to believe that the defendant has committed an offense
- ☐ for which a maximum term of imprisonment of ten years or more is prescribed in _____

Part III - Directions Regarding Detention

The defendant is committed to the custody of the Attorney General or his designated representative for confinement in a corrections facility separate, to the extent practicable, from persons awaiting or serving sentences or being held in custody pending appeal. The defendant shall be afforded a reasonable opportunity for private consultation with defense counsel. On order of a court of the United States or on request of an attorney for the Government, the person in charge of the corrections facility shall deliver the defendant to the United States marshal for the purpose of an appearance in connection with a court proceeding.

Part II - Written Statement of Reasons for Detention

The law has a series of factors I need to look at to determine whether there are conditions of release that will assure your appearance and the safety of other persons in the community.

The first factor is the nature and circumstances of the offense charged, including whether the offense is a crime of violence. By case law these possession of firearms are considered crimes of violence, so that is a negative. The offense also obviously involves a firearm which is a negative.

The next factor is the weight of the evidence. There has been a Grand Jury determination so that is a negative.

The next factor is the person's history and characteristics, which includes you physical or mental condition. I do not see anything there that is a negative.

Family ties would be positive based on you mother's offer to provide a residence.

Employment is negative since it does not appear that you have had any stable employment for a period of time.

The next factor is financial resources. There is no indication that you have substantial resources to assist you in fleeing so that would be positive.

Length of residence in the community is positive.

Community ties are positive.

The next factor is past conduct, which includes history relating to drug or alcohol abuse, criminal history, and record concerning appearance at court proceedings. You have had numerous occasions where you have been either convicted and sentenced or released on probation where you have not done well. Even if I could come up with conditions, I do not have any reason to believe that you would follow them.

The next factor is whether at the time of the current offense or arrest you were on probation or parole.

You were, so that is another negative.

The final factor is the nature and seriousness of the danger to any person in the community that would be posed by your release. Someone that has prior problems with guns is a serious danger.

For all those reasons you are going to remain detained.
