Part II - Written Statement of Reasons for Detention

The statute provides a series of factors I have to look at to determine whether or not there are conditions that I think can be set and followed that will assure your appearance and the safety of the community.

The first factor is the nature and circumstances of the offense charged, including whether it involves a controlled substance. This clearly does so that is a negative factor.

The next factor is the weight of the evidence. There has been a Grand Jury determination of probable cause so that is a negative factor.

The next factor is the history and characteristics of the person, which includes your character and physical and mental condition. Those do not appear to be a problem, so those are positive.

Family ties appear to be positive.

Employment is somewhat mixed since you do not actually have a job with someone else but you are taking care of property.

The next factor is financial resources. There is no indication that you have liquid resources that would assist you in fleeing so that is a positive.

Length of residence in the community and community ties are positive.

Your problem is past conduct, which includes history relating to drug or alcohol abuse, criminal history, and record concerning appearances at court proceedings. There are numerous times you have failed to appear when you are ordered to appear and you failed to comply with conditions.

The next factor is whether at the time of the current offense you were on probation, parole, or other release. You were, so that is another problem.

The final factor is the nature and seriousness of the danger to any person in the community that would be posed by your release. Any time you are charged with distributing illegal substances that is a danger. Taking all of those factors into consideration, it does not appear to me that there are conditions I can set that I think you will comply with so you will remain detained.
