ORDER OF DETENTION PENDING TRIAL

In accordance with the Bail Reform Act, 18 U.S.C. § 3142(f), a detention hearing has been held. I conclude that the following facts require the detention of the defendant pending trial in this case.

Part I - Findings of Fact

- (1) The defendant is charged with an offense described in 18 U.S.C. § 3142(f)(1) and has been convicted of a (federal offense) (state or local offense that would have been a federal offense if a circumstance giving rise to federal jurisdiction had existed) that is
a crime of violence as defined in 18 U.S.C. § 3156(a)(4).
an offense for which the maximum sentence is life imprisonment or death.
an offense for which a maximum term of imprisonment of ten years or more is prescribed in
a felony that was committed after the defendant had been convicted of two or more prior federal offenses described in 18 U.S.C. § 3142(f) (1)(A)-(C), or comparable state or local offenses.
(2) The offense described in finding (1) was committed while the defendant was on release pending trial for a federal, state or local offense.
(3) A period of not more than five years has elapsed since the (date of conviction) (release of the defendant from imprisonment) for the offense described in finding (1).
(4) Findings Nos. (1), (2) and (3) establish a rebuttable presumption that no condition or combination of conditions will reasonably assure the safety of (an)other person(s) and the community. I further find that the defendant has not rebutted this presumption.

Alternative Findings (A)

- (1) There is probable cause to believe that the defendant has committed an offense
for which a maximum term of imprisonment of ten years or more is prescribed in
under 18 U.S.C. § 924(c).
(2) The defendant has not rebutted the presumption established by finding 1 that no condition or combination of conditions will reasonably assure the appearance of the defendant as required and the safety of the community.

Alternative Findings (B)

- (1) There is a serious risk that the defendant will not appear.
(2) There is a serious risk that the defendant will endanger the safety of another person or the community.

Part II - Written Statement of Reasons for Detention

I find that the credible testimony and information submitted at the hearing establishes by (clear and convincing evidence) (a preponderance of the evidence) that

Part III - Directions Regarding Detention

The defendant is committed to the custody of the Attorney General or his designated representative for confinement in a corrections facility separate, to the extent practicable, from persons awaiting or serving sentences or being held in custody pending appeal. The defendant shall be afforded a reasonable opportunity for private consultation with defense counsel. On order of a court of the United States or on request of an attorney for the Government, the person in charge of the corrections facility shall deliver the defendant to the United States marshal for the purpose of an appearance in connection with a court proceeding.

Part II - Written Statement of Reasons for Detention

There are a series of factors contained in Title 18 U.S.C. §3142(g) that I have to consider to determine whether there are conditions that will reasonably assure your appearance and the safety of any other person in the community.

The first factor is the nature and circumstances of the offense charged including whether it involves a minor victim, which this does, so that is a negative factor.

The next factor is the weight of the evidence. There has been a Grand Jury Indictment so that is negative.

The next factor is the history and characteristics of the person, including your character, physical and mental condition. Obviously there are issues about your mental condition based on your behavior and your statements.

Family ties are positive.

Employment is positive.

The next factor is financial resources. There is no indication that you have substantial resources that would assist you in fleeing so that is positive.

Length of residence in the community is positive.

Community ties are positive.

The next factor is past conduct, which includes history relating to drug and alcohol abuse, criminal history, and record concerning appearance at court proceedings. Obviously your problems are related to alcohol abuse and the criminal history that has resulted from that alcohol abuse.

The next factor is whether at the time of the current offense or arrest you were on probation, parole, or other release. It appears that you were on some form on conditions and that you were

waiting to be sentenced.

The final factor is the nature and seriousness of the danger to any person in the community that would be posed by your release.

Taking all those factors together, along with the presumption of detention for this offense unless you rebut the presumption, I am going to find that you are to remain detained pending the conclusion of this matter.
